

When entering the parking lot, the following regulations apply to the parking lot user

1. General

When the vehicle is stopped, a contract for a truck parking space is concluded. Only vehicles approved for public transport may be parked. The following conditions are recognized as part of the concluded contract. The user is obliged to observe the parking regulations.

2. Parking fee

The parking fee is to be paid unsolicited to the cashier in the sales shop after 5 p.m. If you park your vehicle without paying the parking fee, you are parking unauthorized and violating Section 123 of the Criminal Code (trespassing). In the event of unauthorized parking, a contractual penalty of € 100 must be paid. In addition, towing costs or storage costs can arise.

Leaving the parking lot is possible at any time after paying the parking fee.

Parking is free for 1.5 hours.

The parking fee is € 10.

The 7 € consumption voucher can be redeemed in the catering trade.

3. Liability of the car park operator Rasthof Zur Schneifel GmbH

Use of the parking lot is at the parker's own risk. The parking lot operator is liable for all damage insofar as it can be proven that it was caused by him or his staff and is also reported before leaving the parking lot. The guarding or safekeeping of the parked vehicle or any other activity that goes beyond the provision of a parking space is not part of the contract. Accordingly, the parking lot operator does not assume any duty of care. Limited winter service!

4. Adjustment of the vehicle

The parker can choose a parking space from free spaces. The parker has to park a vehicle in such a way that unhindered use of the neighboring parking spaces is possible at all times, and the tramlines are always kept clear. Incorrectly parked vehicles can be towed away at the parker's expense. The parking lot and its facilities are to be used carefully and appropriately. Any damage will be removed at the Parker's expense. Parking vehicles with leaking fuel tanks or fuel lines is not permitted. The parker has to be shown in the parking lot as is customary and to secure his vehicle accordingly.

5. Video surveillance and data protection

Information on video surveillance (Art. 13 DSGVO) - The parking lot, parts of the petrol station area and the sales shop, as well as supplier and staff room access, are partially video-monitored. We process your data for the purpose of preventing and detecting criminal offenses (Art. 6 f DSGVO) to protect our customers, employees and our property. In principle, we store your data for a max. 72 hours and only pass them on to maintenance and security service providers commissioned by us and, if necessary, to law enforcement authorities and lawyers for legal enforcement.

Reference to the rights of those affected

Upon request, we will be happy to inform you whether and which data is stored about you. As far as the legal requirements are met, you have the right to correct, block or delete this data. You also have the right to data portability. You have the right to object at any time to the processing of personal data relating to you for reasons that arise from your particular situation. You also have the right to lodge a complaint with the competent supervisory authority for data protection.

6. Parker's Liability

The parker is liable for all damage caused. He is obliged to report the damage caused to the parking lot operator and the police immediately. The StVO applies - you can only drive at walking pace.

It is forbidden:

- The storage of any items
- The parking of trailers or semitrailers without a tractor
- Leaving the engine running unnecessarily
- Parking vehicles that are leaking oil or fuel
- Cleaning the vehicle and repairs
- Open fire, gas cooker, grilling
- Noise pollution after 10 p.m. is prohibited
- Dispose of larger amounts of rubbish. -> Waste containers are available for the usual small quantities. THANK YOU.
- Peeing and shitting are prohibited in the parking lot -> we also have very nice toilets in the service area during business hours and after business hours there is an outside toilet on the truck filling station side available free of charge! THANK YOU!
